Beginning at a point which is south 9° 00' west 280 feet from a point which is south 1257 feet and west 38.93 feet from the common corner of sections 15, 16, 21 and 22, in township 2 north of range 7 east of the Willamette Meridian, and running thence north 81° 00' West 100 feet; thence south 9° 00' west 52 feet to the northerly line of the Spokane, Portland & Seattle Railway Company's right of way; thence easterly, along said northerly line, to a point which is south 9° 00' west 59 feet from the place of beginning; and thence north 9° 00' east 59 feet to the place of beginning, said tract being designated as lot 1 in block 6, of the unrecorded plat of the town of North Bonneville, Skamania County, Washington.
