Know all men by these presents, That we, Hiram U. Welch and Eva M. Welch, his wife, of Multnomah County State of Oregon in consideration of One (\$1.00) Dollar to them paid by Harold A. Smith and Edith E. Smith, his wife of Multnomah County, State of Oregon, have BARGAINED and SOLD, and by these presents do Grant, Bargain, Sell and Convey unto said Harold A. Smith and Edith E. Smith, his wife, their heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington:

Beginning at a point in the center line of the Washougal River which point is two hundred and fifty feet (250') south of the Easterly extension of the north line of Lot twelve (12) Washougal Riverside tracts as platted in Skamania County, Washington, thence Easterly and parallel to the Easterly extension of the north line of said lot twelve (12), three hundred and thirty-two feet (332') thence northeasterly and parallel to the center line of the Washougal River to an intersection with a line one hundred and twenty-five feet (125') south of and parallel to the easterly extension of the north line of said lot twelve (12); thence westerly three hundred and thirty-two feet (332') along the line one hundred and twenty-five feet (125') south of and parallel to the easterly extension of the north line of said lot twelve (12) to the center line of the Washougal River; thence down stream along the center line of the Washougal River to the point of beginning, except pipe line easements to D. B. Ambler and Adelle Amber, his wife,

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and also all their estate, right, title and interest in and to the same including dower and claim of dower.
