Warranty Deed.

The Grantor, Moffetts Hot Springs Co., a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, does hereby CONVEY and WARRANT unto Bert Jarvis, hereinafter referred to as the grantee, the following described real property, to-wit:

Beginning at a point on the Southerly line of the Evergreen Highway which is South 1257 feet and West 38.93 feet from the common corner of Section 15, 16, 21 and 22, in Township 2 North of Range 7 East of the Willamette Meridian, and running thence north 81° 00' West, along said highway, 850 feet; thence north 79° 51' West, along said highway, 850 feet to a point which is the true point of beginning of the tract herein described; and running thence north 79° 51' West, along said highway, 75 feet; thence south 10° 09' West 22.805 feet; thence south 71° 40' East 75.771 feet, more or less, to a point that is south 10° 09' West from the place of beginning; thence north 10° 09' east 33.56 feet to the place of beginning, said tract being designated as all of Lot 26 and the East 25 feet of Lot 27 in Block 4 of the unrecorded plat of the Town of North Bonneville, in Skamania County, Washington.
