PIONEER PRINT, STEVENSON, WASH.

Know all men by these presents, That Mary V. Lane, dealing with her separate inherited property of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One Dollars, in hand paid, the receipt whereof is hereby acknowledged has GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents does Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcels of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all those portions of the following described tracts of land that lie southwardly from a line parallel with and distant 60 feet northwardly (measured at right angles) from the center line of of State Road No. 8, Underwood Vicinity as surveyed over and across Lot 6, Block 1 of Underwood Townsite, except that from the west line of of said lot 6 and the northerly projection of said west line to Engineering survey station 704 plus 00 said strip of land lies southwardly from a line parallel with and distant 70 feet northwardly (measured at right angles from the center line of said State Road No. 8, and from Engineering survey station 704 plus 00 to the west line of hereinafter described Government Lot 1, said strip of land lies southwardly from a line parallel with and distant 100 feet northwardly (measured at right angles from the center line of said State Road No. 8 as surveyed over and across Lots 10, 11, 12 Block 1 1st Addition to Underwood Townsite and that portion of Government Lot No. 1, section 23, township 3 north, range 10 East of the Willamette Meridian that lies northwardly from the right of way of the Spokane, Portland & Seattle Railway and northwardly from the county road, now existing State Road No. 8, except platted areas.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval March 6th, 1934. Revised Nov. 21, 1934. This deed supersedes and cancels deed from the above named grantor to said State of Washington, dated Jan'y. 16, 1935 and is given for the purpose of correcting description so that dwelling of grantor's may be entirely on her land. It is understood that spring, spring house and signal site are on grantor's land.

Said deed heretofore given and hereby superseded and cancelled is dated January 16th, 1935, recorded February 2nd, 1935 in Vol. Y of Deeds at page 100.
