FIRST SUPPLEMENTAL INDENTURE

THIS INDENTURE, dated as of the first day of April, 1950, made and entered into by and between PACIFIC POWER & LIGHT COMPANY, a corporation of the State of Maine, whose post office address is Public Service Building, Portland, Oregon (hereinafter sometimes called the Company), party of the first part, and GUARANTY TRUST COMPANY OF NEW YORK, a corporation of the State of New York, whose post office address is 140 Broadway, New York, New York (hereinafter sometimes called the Corporate Trustee), and OLIVER R. BROOKS, whose post office address is 260 West Jersey Street, Elizabeth, New Jersey (hereinafter sometimes called the Co-Trustee), parties of the second part (the Corporate Trustee and the Co-Trustee being hereinafter together sometimes called the Trustees) as Trustees under the Mortgage and Deed of Trust, dated as of July 1, 1947 (hereinafter called the Mortgage), executed and delivered by Pacific Power & Light Company to secure the payment of bonds issued or to be issued under and in accordance with the provisions of the Mortgage, this indenture (hereinafter called First Supplemental Indenture) being supplemental thereto.

Whereas the Mortgage was filed for record, and was recorded and indexed, as a mortgage of both real and personal property, in the official records of the several counties in the state of Oregon and Washington listed below, as follows:
