THIS INDENTURE, Made this 3rd day of July, 1935, between C C Hon, as Treasurer of Skamania County, State of Washington, party of the first part, and Rainbow Mining Company, a corporation of Vancouver, Wn party of the second part; pursuant to the provisions of Contracts No. 77, 78, and 79,

WITNESSETH, THAT WHEREAS, At a public sale of real estate held on the 31st day of August, A. D. 1929, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,
