## MORTGAGE

THIS INDENTURE, Made this 4th day of May in the year of our Lord one thousand nine hundred and fifty BETWEEN JOHN E. STRAIN and CHARLOTTE E. STRAIN, husband and wife now and at all times since prior to acquiring title to the real property hereinafter described, parties of the first part, and SECURITY STATE BANK, White Salmon, Washington a corporation duly organized and existing under the laws of Washington a party of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of THREE THOUSAND FIVE HUNDRED and NO/100 DOLLARS, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its successors and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:
