The Grantor, Moffetts Hot Springs Company, a Washington corporation, for and in consideration of the sum of Eight Hundred (\$800.00) Dollars and other good and valuable consideration, does hereby CONVEY and WARRANT unto Mrs. E. Schedin and Mrs. W. Carlson, hereinafter referred to as the grantees, the following described real property, to-wit:

Beginning at a point which is south 9° 00' West 160 feet from a point on the southerly line of the Evergreen Highway which is south 1257 feet and west 38.93 feet from the common corner of sections 15, 16, 21 and 22, in township 2 north of range 7 East of the Willamette Meridian and running thence north 81° 00' West 25 feet; thence south 9° 00' West 40 feet; thence south 81° 00' east 25 feet; and thence north 9° 00' East 40 feet to the place of beginning, said tract being designated as the East 25 feet of Lot 4, in Block 6, of the unrecorded plat of North Bonneville, Skamania County, Washington.
