Commencing at a point three hundred and fourty three feet (343) west of the quarter stake between section 25 and 26 then running in a westerly direction, two hundred and sixty seven feet (267) to the East line of Lot 10, then in a southerly direction along the East line of lot 10 to the right of way of the County road, about one hundred and ninty feet (190) then along the right of way of the north line of the county road about three hundred and thirty three feet (333) then due north to the place of beginning.
