Mansuetto Tavelli to Margarite D. Shields

This Agreement made and entered into by and between Mansuetto Tavelli, a widower, party of the first part, and Margarite D. Shields, a widow, party of the second part, Witnesseth:

That the party of the first part for and in consideration of the sum of Fourteen Hund-
red and 00/100 (\$1400.00) Dollars, to be paid as hereinafter provided does hereby covenant
and agree to sell and convey unto the party of the second part, and the party of the second
part agrees to purchase from the party of the first part, the following described real pro-
perty in Skamania County, Washington, to-wit:

1. Commencing at a point at the southwest corner of the McPherson's lot, which is a point on the north line of the road known and designated as State Road #8 on March 27, 1922, thence south 83° west along the north line of said state road 14.55 chains to the west line of the SW $\frac{1}{4}$ of Section 3, Township 1 North range 5 East of Willamette Meridian, thence north 00° 40' West along said west line of the SW $\frac{1}{4}$ of said section 8.29 chains to the southwest corner of the Harris lot, being also known as the tract conveyed to H. B. McDonald by deed at page 539 Book "V"
