Betty Jorden to The Public

Declaration of Homestead

Know all men by these presents, That Betty Jorden, a married woman, does hereby certify and declare as follows:

1. That she is a married woman and is the head of a family, to-wit: the mother of two minor children, now residing with, and depending upon her for their support. That her husband's name is Leo Jorden, and that her said husband has never made a declaration of homestead or claimed a homestead right, and that her said husband has abandoned her and their family, and that his present whereabouts are unknown to her, and that for some time past, said husband has failed to support her and/or her family, and that she makes this declaration for the purpose of securing for her and her family, the benefits of the homestead act of the State of Washington.
