Warranty Deed.

This Deed, made this 14th day of August, 1935, by and between The Mt. St. Helens Consolidated Mining Co., party of the first part, and the United States of America, party of the second part,

Witnesseth: That whereas the said party of the first part has filed its application for exchange of certain lands with the United States, under the terms of the Act of Congress of March 20, 1922, entitled, "An Act to Consolidate National Forest Lands", - Vol. 42, United States Statutes at Large, page 465; and

Whereas, an application has been submitted by the party of the first part to the Secretary of the Interior to exchange the tracts hereinafter described for timber on the \_\_\_\_\_ National Forest, in accordance with the said Act of Congress;

Now, Therefore, in consideration of the premises and for the purpose of effecting such exchange, the said party of the first part does hereby GRANT, BARGAIN, SELL and CONVEY unto the said party of the second part, all of the following tracts or parcels of land lying and being in the County of Skamania, State of Washington, to-wit:

Mineral Survey Lot No. 620 (44.999 acres); Mineral Survey Lot No. 621 (37.434); Mineral Survey Lot No. 774 (266.148) acres) Mineral Survey Lot No. 779 (247.932 acres); Mineral Survey Lot No. 780 (99.274 acres) and Mineral Survey Lot No. 781-A (513.249 acres), as patented by the United States, less the four following described tracts:

Beginning at a point on the gravel bed at Harmony Point, at mouth of Greek and south 44 degrees 34' west 23.2 feet from U. S. Mine Location Monument No. 7; thence north 88 degrees 28' East, 410.8 feet; thence north 4 degrees 3' west 580.2 feet; thence south 88 degrees 28' East 378.9 feet, to the westerly line of the Falls Lode Mining claim and the east shore of Spirit Lake; thence south 13 degrees 24' East 170.75 feet along said line of said mining claim; thence along said westerly line of said mining claim 4 degrees 3' west 414.5 feet to the point of beginning, containing 5 acres more or less, being a part of the said Falls Lode Mining Claim and being located in section 12, T. 9 N., R 5 E.
