Gillette et ux et al by deed recorded at page 402, Book "O" of Deeds, records of Skamania County, Washington, said corner being a point on center line of section 36, township 3 north range 7 East of Willamette Meridian 469 feet south of the center of said section; thence west 90 feet; thence north 198 feet to the initial point of the tract of land hereby conveyed; thence from said initial point west 220 feet to the west side of the above mentioned tract of land conveyed to S. T.
