Beginning at a point on the north boundary of the S. P. & S. Railway right of way, which is approximately 150 feet and due south of the NE corner of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of sec. 35, Tsp. 2 North of range 6, E. W. M., thence in a westerly direction along the northern boundary of the S. P. & S. Railway right of way, 265 feet to the true point of beginning of the tract herein described and which point is designated by a one inch iron pipe driven into the ground; thence westerly along the said north boundary of the S.
