Belle M. Morris to Robt. A. Lowe et al

This Indenture made and entered into this 25th day of September, 1935, by and between
Belle M. Morris, who is now and who was at the time she acquired title to the hereinafter
described property, a widow, by Hattie L. Brown, her attorney-in-fact, party of the first
part, and Robert A. Lowe, Herbert A. Lowe and Wilma Lowe, parties of the second part,
WITNESSETH:

That for and in consideration of the sum of One Dollar, the receipt whereof is hereby
acknowledged, the party of the first part does hereby BARGAIN, SELL and CONVEY unto the
parties of the second part, the following described parcel or tract of land situate in the
County of Skamania, State of Washington, to-wit:

Beginning at a point on the north boundary line of State Highway No. 8 (as
located and established on the 29th day of October, 1921) 1474 feet west of
the line between sections 21 and 22 in township 2 N. R. 7 E. W. M., and run-
ning thence north to Bass Lake, thence westerly following the short line of
said lake to a point 100 feet west of the north and south line just described,
thence south to the highway above mentioned and described, thence easterly
along the said highway to the point of beginning.

To Have and To Hold unto the parties of the second part, their heirs and assigns forever.

And the said party of the first part, for her heirs, executors and administrators does
hereby covenant to and with the parties of the second part, their heirs and assigns, that
she is the owner in fee simple of said premises, that the same are free from incumbrances
except contract for sale in favor of the parties of the second part, pursuant to which this
conveyance is made, and that she will, and her heirs shall, forever WARRANT and DEFEND the
title against all lawful claims, except as to the acts of the parties of the second part.
