To secure the performance of the covenants and agreements hereinafter contained, and the payment of Two thousand eight hundred and twenty-five and no/100 dollars with interest from date until paid, according to the terms of one certain promissory note bearing even date herewith. Should the mortgagor default in any of the foregoing covenants or agreements, then the mortgagee may perform the same and may pay any part or all of principal and interest of any prior incumbrance or of insurance premiums or other charges secured hereby, and any amount so paid, with interest thereon at the highest legal rate from date of payment shall be repayable by the mortgagor on demand, and shall also be secured by this mortgage without waiver of any
