The parties of the second part promise and agree that they will punctually pay all the installments aforesaid and will faithfully perform all the terms and conditions contained in this contract and that upon failure so to do, the said party of the first part or his successors or assigns may at their option, rescind this contract and immediately declare all unpaid installments due and payable.
- 5. It is understood and agreed that the stipulations and covenants herein contained are to apply to and bind the heirs, executors, administrators and assigns of the respective parties.
- 6. No assignment of this contract shall be valid until one half of the purchase price shall have been paid unless consented to by the said parties of the first part in writing.
 - 7. Time is of the essence of this contract.
