WARRANTY DEED

(Individual)

THIS DEED, made this tenth (10th) day of October 1935, by and between Leon Liebes and Arnold Liebes, parties of the first part, and the United States of America, party of the second part,

WITNESSETH; That whereas the said parties of the first part have filed an application for exchange of certain lands with the United States, under the terms of the Act of Congress of March 20, 1922, entitled, "An Act to Consolidate National Forest Lands", Vol. 42, United States Statutes at Large, page 465; and

WHEREAS, an application has been submitted by the parties of the first part to the Secretary of the Interior to exchange the tracts hereinafter described for timber on the _____ National Forest, in accordance with the said Act of Congress:
