That whereas the parties of the first part heretofore contracted to sell to E. L. Silvers the real property hereinafter described, and thereafter conveyance was made and delivered to the said E. L. Silvers, but by inadvertance the said real property was described therein as the East Half of Lot 2, Block 1 of Bonnevista Addition, and

Whereas the above named grantee is the successor in interest to the title of said E.L. Silvers,

Now, therefore, in consideration of the sum of one dollar, and for the purpose of correcting the description to the property intended to be conveyed, the parties of the first part do hereby grant, bargain sell and convey unto the party of the second part the following described real property in Skamania County, Washington to-wit:

The Easterly half of Lot two (2) in Block one (1) of Bonnevista Addition to North Bonneville, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, which is particularly described as follows, to-wit:

Commencing at the Southeast corner of said Lot two, thence westerly along the south line of said lot two a distance of 25 feet, thence at right angle and parallel to the east line of said lot two northerly to the north line of said lot two, thence easterly a distance of 25 feet along the north line of said lot two to the northeast corner of said lot two, thence along the easterly line of said lot two to the point of beginning.
