Beginning at a point on the Northerly line of the Evergreen Highway 860.08 feet South and 2005.14 feet West of the Northeast corner of Section 21 in Township 2 North of Range 7 East of the Willamette Meridian, and running thence North 0°48' West 201.6 feet; thence Westerly, on a curve concentric with and 230 feet from the center line of said highway, 263.01 feet; thence Northerly at right angles to a line which is tangent to said last described course at this point, 50 feet; thence Easterly, on a curve concentric with and 280 feet from the center line of said highway, to a point which is North 0°48' West from the place of beginning; thence North 0°48' West 100 feet; thence Easterly, on a curve concentric with and 380 feet from the center line of said highway, to a point which is North 89°12' East 50 feet from said last mentioned course; thence South 0°48' East to the Northerly line of said Evergreen Highway; and thence Westerly, along said Northerly line, to the place of beginning.
