A. B. Herndobler et ux to Albert H. Herndobler

KNOW ALL MEN BY THESE PRESENTS, That A. B. Herndobler and Minnie Herndobler, husband and wife, in consideration of Ten & no/100 Dollars, to us paid by Albert H. Herndobler do hereby grant, bargain, sell and convey unto said Albert H. Herndobler his heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

The East One-half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of the Southeast Quarter ($\frac{1}{4}$) of Section Six (6) Township One (1) North of Range Five (5) East of the Willamette Meridian, containing Twenty (20) acres. As a part of the consideration of this deed the Grantors hereby reserve to the Northwestern Electric Company the right to carry power over two (2) pole lines with wires suspended over the Southwest corner of the land above described, but no right to erect poles on the herein granted land is reserved. The said right to suspend wires having been heretofore granted.

The West One-Half of the S. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of Sec. 6, Township 1, North of R. 5, E. of the Willamette Meridian.

Also:

The East Half ($\frac{1}{2}$) of the Southeast Quarter ($\frac{1}{4}$) of the Southeast Quarter ($\frac{1}{4}$) of Section Six (6) Township One (1) North of Range Five (5) East of the Willamette Meridian, containing Twenty (20) acres, more or less.

To Have and to Hold, the above described and granted premises unto the said Albert H. Herndobler his heirs and assigns forever.

And the grantors above named do covenant to and with the above named grantee his heirs and assigns that they are lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances, and that they will and their heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
