Quitclaim Deed.

Know all men by these presents that we, Julia E. Eddy and Lewis E. Eddy, husband and wife, of Oakland, California, and Lucy Mason, a widow of Henry F. Mason, deceased, of Topeka Kansas, and Arthur A. Greene and Gretchen Greene, husband and wife, of Honolulu, Hawaii and Caroline Keller, unmarried, of Hood River, Oregon, being the heirs of and all of the persons interested in the estate of Julia Greene, who was the widow of Albert R. Greene, the said Julia Greene and Albert R. Greene both being deceased, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, do hereby REMISE, RELEASE and forever QUITCLAIM unto Jennie Harris, a widow, all of our right, title estate, lien and interest in and to the following described premises in the County of Skamania, State of Washington, to-wit:

Lot six (6) Block three (3), Johnson's Addition to the Town of Stevenson, Washington, according to the official plat of Cascades Addition and the North half of Block three (3) Johnson's Addition to the Town of Stevenson, Washington, recorded on page 62 in Plat Book A of records of Skamania County, Washington, and more particularly described as follows: Commencing at a point on the south side of Rose Lawn St. 250 feet West of the Northeast corner of said block 3 Johnson's Addition to the Town of Stevenson, Washington, thence west 173 feet; thence south 26.69 feet; thence south 28° 31' East 82.54 feet; thence east 133.16 feet; thence north 100 feet to the place of beginning. Which tract herein conveyed abuts on a public alley on the north 20 feet in width, which is hereby dedicated, and extending from the southwest corner of Roselawn and Willard streets West a distance of 123 feet, to the Northwest corner of the said Lot 6 in Block 3.
