KNOW ALL MEN BY THESE PRESENTS, That on this 27th day of November, 1950, L. B. Johnston and Violet M. Johnston, husband and wife, and Roy H. Dobbs and Veta M. Dobbs, husband and wife, hereinafter called the Mortgagors, hereby grant, bargain, sell, convey and mortgage to THE FEDERAL LAND BANK OF SPOKANE, a corporation organized and existing under the Federal Farm Loan Act, with its principal place of business in the City of Spokane, County of Spokane, State of Washington, hereinafter called the Mortgagee, the following described real estate situate in the County of Skamania, State of Washington, to wit:

Lot 1 and the Northwest Quarter of Section Sixteen, Township One North, Range Five East of the Willamette Meridian.
Also, Lot 1, the North Half of the Southeast Quarter, and the Southwest Quarter of the Southeast Quarter of Section Sixteen, Township One North, Range Five East of the Willamette Meridian.
Also, Lot 3 of Section Twenty, Township One North, Range Five East of the Willamette Meridian.
Also, all shore lands situate in front of, adjacent to, or abutting upon the Government Meander line described as follows: Commencing at the Government Meander post between Sections Sixteen and Seventeen, Township One North, Range Five East of the Willamette Meridian, thence along the Government Meander line downstream to near the center of Section Twenty, Township One North, Range Five East of the Willamette Meridian, being a total of 55 chains measured along the Government Meander line.
Subject to: (1) A strip of land 100 feet in width acquired by condemnation by the Portland and Seattle Railway Company.
(2) Easements, rights of way, and a strip of land on, over, across, and through the above described property granted to and acquired by the State of Washington and Skamania County.
