Jones, his wife, (both deceased,) being of lawful age, in consideration of Fifty and no/100 Dollars to me paid by John Kraetch, of Portland, Oregon do hereby remise, release and forever QUITCLAIM unto the said John Kraetch and unto his heirs and assigns, all my rights, title and interest in and to all that parcel of real estate situate in County of Skamania State of Washington, to-wit:

The Samuel M. and Mary Jane Hamilton Donation Land Claim, designated as claim number 40, being parts of Sections 19, 20, 29 and 30, containing 643. acres; The Samuel M. Hamilton Homestead, being Lots numbered 1, 5, and 6 of Section 29, and Lots numbered 5 and 6 of Section 30; and all lands commonly designated "shore lands" fronting or adjoining the premises above described; all in Township Two Norgh, Range Seven East of Willamette Meridian, in Skamania County, State of Washington. This conveyance also includes the parcel of land deeded by S.M. Hamilton and Mary J. Hamilton, his wife to Samuel B. Jones, March 19, 1868 and recorded in Book "B" of Deeds, page 71, and correction deed dated July 30, 1881 recorded in Book "C" of Deeds, page 155 and described as follows:- "The following described piece of land, situated at Lower Cascades Skamania Co.
