as follows: Thence Northeasterly on said southerly right of way line of said road Number 8, a 2835.00 feet radius curve line to the right which is concentric with and thirty feet southeasterly of as measured on a radial line from the center line of said road No. 8, 180.71 feet, the long chord of said curve line bears North 80° 29' 17" E., 180.70 feet to the northeast corner of said parcel of land; thence South 16°33' East 247.35 feet to the southeast corner of Greenleaf Cemetery; thence South 68°35' West 184.74 feet to the Southwest corner of said cemetery; thence North 15° 36' West 285.20 feet to the northwest corner of said parcel at the point of beginning, containing 1.12 acres, more or less. This description includes the original tract known as Greenleaf Cemetery and a narrow strip between the north line of said cemetery and Washington State Road Number 8, in Skamania County, Wash."
