Fred H. Twohy to State of Washington

THIS INDENTURE, Made the 2 day of November in the year of our Lord one thousand nine hundred and thirty-five between Fred H. Twohy, the party of the first part and the State of Washington, the party of the second part.

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of (\$1.00) one dollar, lawful money of the United States of America to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents remise, release convey and forever quit claim unto the said party of the second part, and to their successors and assigns all of a certain parcel of land situated in the County of Skamania, State of Washington, and bounded and particularly described as follows, to-wit:

All of the South West quarter (S.W. $\frac{1}{4}$ ) of the South East quarter (S.E. $\frac{1}{4}$ ) of section 14, and the West-half (W $\frac{1}{2}$ ) of the North East quarter (N.E. $\frac{1}{4}$ ), and the South-east quarter (S.E. $\frac{1}{4}$ ) of the North East quarter (N.E. $\frac{1}{4}$ ) of section 23, in Township two (2) North of Range Six, east of the Willamette Meridian in the said county of Skamania, State of Washington, containing one hundred and sixty acres.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, All and singular, the said premises, together with the appurtenances, unto said party of the second part, and to their successors and assigns forever for State Park purposes only.
