THIS INDENTURE, Made this 21st day of November, 1934, between A.C.Sly, as Treasurer of Skamania County, State of Washington, party of the first part, and John Kraetch 533 NE Fargo St. Portland, Ore. party of the second part;

WITNESSETH, THAT WHEREAS, At a public sale of real estate held on the 29th day of October, A.D. 1932, pursuant to an order of the Board of County Commissioners of the Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,
