That the said parties of the first part for and in consideration of the sum of Three hundred twelve and 66/100 (\$312.66) to them in hand paid by the party of the second part the receipt whereof is hereby confessed, do hereby grant, bargain, sell and convey unto the said party of the second part, its successors and assigns, the following described real property in Skamania County, Washington, to-wit:

Beginning at a point 354 feet south and 30 feet east of the Northwest corner of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ sec. 20 tp 3 N R 8 E. W.M., running thence north 145 feet, more or less to the southwest corner of the square acre of land deeded to School District No. 8 by A. S.
