This is a memorandum of the agreement this day made between W. C. Culbertson and Charlotte Culbertson, his wife, parties of the first part, and F. N. Kendall and Alma N. Kendall his wife, parties of the second part, concerning first parties' contract to purchase from second parties the Kenridge property, in Skamania County, Washington, one and a half miles east of Prindle.
