WARRANTY DEED

THE GRANTOR, MOFFETTS HOT SPRINGS CO., A Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, does hereby convey and warrant unto Bert Jarvis, hereinafter referred to as the grantee, the following described real property, to wit:

Beginning at a point which is South 9°00' West 160 feet and North 81°00' West 25 feet from a point on the Southerly line of the Evergreen Highway which is South 1257 feet and West 38.93 feet from the common corner of Sections 15, 16, 21 and 22, in Township 2 North of Range 7 East of the Willamette Meridian, and running thence North 81°00' West 75 feet; thence South 9°00' West 40 feet; thence South 81°00' East 75 feet; and thence North 9°00' East 40 feet to the place of beginning, said tract being designated as the West 75 feet of Lot 4, in Block 6, of the unrecorded plat of North Bonneville, Skamania County, Washington.
