Beginning at a point on the southerly line of the Evergreen Highway which is south 1257 feet and west 38.93 from the common corner of Sections 15, 16, 21 and 22, in Town-ship 2 North of Range 7 East of the Willamette Meridian, and running thence north 81 deg. 00' west 850 feet; thence north 79 deg. 51' west 400 feet to the true place of beginning of the property herein described; and running thence north 79 deg. 51' west 50 feet; thence south 10 deg. 09' west 50 feet; thence south 79 deg. 51' east 50 feet; and thence North 10 deg. 09' east 50 feet to the place of beginning, said tract being also designated as the north fifty feet of Lot 17 in Block 4 of the unrecorded plat of the Town of North Bonneville, Skamania County, Wash.
