mania County, Washington, the right of way for a water flume in which to flume timber products over and across the lands hereinafter described, together with the privilege of entering in and upon said premises to erect the same and shall be of a width of twenty five (25) feet, and the privileges granted hereunder are so granted to continue and exist for a period of ninety nine (99) years from and after the date of this instrument. The land across which said right of way is granted by this deed, is described as follows:

Southeast Quarter (SE $\frac{1}{4}$) of Northeast Quarter (NE $\frac{1}{4}$) of Section twenty six (26), township Three (3) North, Range nine (9) East, W.M.

It is agreed between the parties of this instrument that work on the reconstruction of said flume can be started at once.

It is agreed that the grantors shall have free, one second foot (1) of water for irrigation purposes, subject to the first and prior right of the Portland Railway Light & Power Company, a corporation of the State of Oregon, of the water passing through said flume connection with said flume to be made at a point on the grantors own land, and said water to be by them used only in such manner and at such times as will not interfere with the conduct of the flume for the purpose for which same is erected.

TO HAVE AND TO HOLD the same unto the said Broughton Lumber Company their heirs and assigns forever.
