Preston Ash et ux to State of Washington

THIS INDENTURE made and entered into this 26th day of May, 1936, by and between Preston Ash and Gertrude E. Ash, husband and wife, parties of the first part, and State of Wash-
ton, party of the second part, Witnesseth:

Whereas, the parties of the first part, together with Bessie Ash Young, heretofore con-
veyed to the Game Commission of Skamania County, Washington, the hereinafter described real
property, and

Whereas, pursuant to the requirements of Initiative Measure No. 62 (Chapter 3 of Laws
of 1935) the said Game Commission did convey the said real property to the State of Washing-
ton, and

Whereas, the conveyance executed by the grantors above named was not placed of record
and has been lost.

Now Therefore, in consideration of the sum of One Dollar and to vest title in the State
of Washington the parties of the first part do hereby Remise, Release and Quitclaim unto the
State of Washington, its successors and assigns, all their right, title and interest in and
to the following described real property, to-wit:

Commencing at a point on the south boundary of State Road No. 8 (as located prior to
1927) South 23° East 116 feet from the quarter corner on the West line of Section 11
Twp. 2 N. R. 7 E. W. M.; thence North 64° 32' East 75.5 feet; thence South 42° 20'
East 303.6 feet; thence South 26° 10' West 190.4 feet to the North boundary of State
Road No. 8 (as located prior to 1927), thence along same North 71° 41' West 25.3 feet
to West line of Bradford D. L. C.; thence along same North 23° 00' West 390 feet to
the initial point, containing .97 acres, more or less.
