A small tract of land described as follows: Beginning at a point 160 feet south of the northeast corner of the SE $\frac{1}{4}$ of Section 27 town 4 North Range 7 East, W. M., thence south 208 feet, thence west 104 feet, thence north 208 feet, thence East 104 feet to place of beginning, containing one-half acres more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
