DECLARATION OF HOMESTEAD

KNOW ALL MENT BY THESE PRESENTS, That I, C. E. McCurdy of North Bonneville, Skamania County, Washington, have declared and do hereby declare and show,

That I am the head of a family; that my said family consists of myself and wife,

That I am now residing on the following described real estate and premises, situate in the County of Skamania and State of Washington, to-wit:

Beginning at a point on the southerly line of the Evergreen Highway which is south 1257 feet and west 38.93 feet from the common corner of Sections 15, 16, 21 and 22, in Township 2 North of range 7 east Willamette meridian, and running thence south 9 deg. 00' West 160 feet; thence south 81 deg. 00' east 625 feet to a point which is the true point of beginning of the tract herein described; and running thence south 81 deg. 00' east 40 feet; thence south 9 deg. 00' west to the northerly line of the Spokane, Portland & Seattle Railway Company's right of way; thence westerly along said right-of-way to a point which is south 9 deg. 00' west from the place of beginning; and thence north 9 deg. 00' east to the place of beginning; said tract may be also designated as the east 25 feet of lot 8 and the west 15 feet of lot 7, (in block 8) (OGH) of the unrecorded plat of the town of North Bonneville, Skamania County, Wash.
