KNOW ALL MEN BY THESE PRESENTS: That I, Oscar G. Heaton, of the town of North Bonneville,
Skamania County, Wash., do hereby declare and show:

That I am the head of a family consisting of my wife and one minor child; that I am now
residing with my said family on the following described real estate and premises situate in s
said county and state, to-wit:

That certain building known as the Heaton building, used for both office and residence,
situate on a tract of gound described as follows:

Beginning at a point on the Southerly line of Evergreen State Highway, which is South
1257 feet and West 38.93 from the common corner of Sections 15, 16, 21 and 22, in Township
2 North of Range 7 East of the Willamette Meridian, and running thence North 81 deg. 00'
West 850 feet; thence North 79 deg. 51' West 400 feet to the true place of beginning of
the property herein described; and running thence North 79 deg. 51' West 50 feet; thence
