That during the month of July 1921 the Game Commission, by a resolution duly entered upon its minutes, purchased from Skamania Light & Power Company a corporation, a certain tract of land adjacent to the Hatchery property on Rock Creek, being all of the land then owned by said Company South of the North corporate limits of the Town of Stevenson in SE½ of SW½ of Section 36, Township 3 North, Renge 7 East of Willamette Meridian. The property so purchased consisted (together with property then owned by the Game Commission) of that tract of land specified in deed from the Skamania County Game Commission to Leon P. Montchalin, recorded at Page 250 Book "X" of Deeds records of Skamania County Washington. The said deed was delivered to me as Chairman of the Game Commission and thereupon the Game Commission issued to the Skamania Light & Power Company its Warrant No. 589 in the sum of \$400.00 in payment of the purchase price. The said warrant was duly registered and paid out of the funds belonging to the said Game Commission in the hand of the County Treasurer on the 27th day of July, 1921.

This deed was placed by me with other records belonging to the Game Commission and not immediately recorded. Shortly thereafter on a trip to Olympia on business pertaining to the Game Commission my automobile was robbed and hand bag containing the file of commission papers was stolen. Arrangments were made to obtain a duplicate of the original deed above referred to but by oversight or inadvertence such deed was not secured. The Skamania County Game Commission claimed title to the above mentioned real property from the time of its purchase as aforesaid until its disorganization and made considerable improvements thereon.
