Declaration of Homestead.

Beginning at a point on the East side of State Road No. 8 as now definitely located and established across the Southeast quarter of Southeast quarter of Section 26, Township 2 North, Range 6 East, W. M., at the point of the inter- section of said State Highway with the center line of the old state road formerly designated as State Highway No. 8, which said point is 720 feet south and 260 feet west of the quarter corner on the east line of said section 26; thence following the easterly line of said state highway No. 8 as now located in a southerly direction a distance of 375 feet; thence at right angles to the tangent of center line of said State Highway No. 8 in an easterly direction to intersection of center line of the old state road; thence in a northerly direction to point of beginning, all in the southeast quarter of said section 26.
