The grantee shall have the right to erect and maintain poles with the necessary cross-arms, wires, anchors and fixtures thereon for telephone and telegraph purposes, and shall have the right to cut and remove shrubbery and foliage from said right of way so that the same shall not interfere with the use of such lines.

The right is also hereby granted the Telephone Company to place and maintain gates in fences at the point or points where the right-of-way intersects said fences.

It is understood that the employees of said Telephone Company shall, at any time when necessary, have access to said right of way and the poles with necessary wires, crossarms and fixtures thereon, for purposes of repairs, replacements, etc., provided always that said Telephone Company shall be responsible for any damage which may be done to the property above described, by reason of such access.
