Henry Peyrollaz to Aline Peyrollaz

This Agreement made and entered into by and between Henry Peyrollaz, party of the first part, and Aline Peyrollaz, party of the second part, Witnesseth:

Whereas, the parties hereto are husband and wife residing within the State of Washington and are the owners of real and personal property situate and being within the State of Washington, all of which is community property acquired by them during the time they have been married and they desire to fix the status of said property as their community estate and to provide for the disposition thereof upon the death of either of them.

Now, Therefore, it is agreed by and between the parties hereto that all of the property which stands of record in the name of either or both of the parties hereto is determined to be and is their community property.

It is further agreed by and between the parties and in consideration of the premises and the benefits hereby accruing to each of them that all of said community property, both real and personal and all community property which shall hereafter be acquired by them, whether the same stands in the name of one or both of them, shall, upon the death of either party, immediately vest in and become the sole, separate and absolute property of the survivor to the exclusion of their children and all their heirs at law and in the manner provided for and permitted by the statutes of the State of Washington with reference to the rights of husband and wife to contract concerning the disposal of their community estate.
