Know All Men by these presents, That Alden Kingman and Emma Kingman husband and wife, grantors, in consideration of the sum of Fifty and no/100 Dollars (\$50.00), the receipt whereof is hereby acknowledged, have GRANTED, and do hereby Grant to Northwestern Electric Company, its successors and assigns, two rights of way for electric power transmission lines across the East half of the Southeast quarter (E_2 of the SE_4) of Section Twenty-seven (27) in township three (3) north of range nine(9) East of the Willamette Meridian, in Skamania County, State of Washington.

The first of said rights of way is for a transmission line as now located, built and operated across said land, the said right of way being twelve (12) feet wide and having the present transmission line as its longitudinal center line. The second of said rights of way is a right of way twelve (12) feet wide and having its longitudinal center line fifty (50) feet northerly from and parallel with the center longitudinal line of the first right or way.

The grantors further grant to the grantee, its successors and assigns, the right to enter upon such rights of way for the purpose of building, maintaining and operating said transmission lines, and to cut such timber and brush as may interfere with or endanger said transmission lines out to a distance of one hundred fifty (150) feet on either side of said transmission lines. This deed is on condition that the grantee shall not have the right to fence or enclose either of said rights of way, and shall not place its poles or towers at a less distance than one hundred (100) feet apart on each of said rights of way.
