Warranty Deed.

The Grantor, Moffetts Hot Springs Co., a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, does hereby CONVEY and WARRANT unto D. D. Compton of North Bonneville, Washington, hereinafter referred to as the grantee, the following described real property, to-wit:

Beginning at a point on the southerly line of the Evergreen Highway which is south 1257 feet and west 38.93 feet from the common corner of sections 15, 16, 21 and 22, in township 2 north of range 7 East of the Willamette Meridian, and running thence north 81° 00' West along said highway, 850 feet; thence north 79° 51' West along said highway, 850 feet to a point which is the true point of beginning of the tract herein described; and running thence south 79° 51' East along said highway 50 feet; thence south 10° 09' West 40.75 feet; thence north 71° 40' West 50.51 feet; and thence north 10° 09' East 33.56 feet to the place of beginning, said tract being designated as lot 25 in Block 4, of the unrecorded plat of the town of North Bonneville, Skamania County, Washington.
