Know all by these presents, That Henry Kapp and Erma M. Kapp his wife, of the County of Skamania, in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of the following described tract of land that lies southwardly from and adjoins the right of way of the Spokane, Portland & Seattle Ry. Co. and northwardly from a line, parallel with and distant 70 feet southwardly (measured at right angles) from the center line of State Road No. 8, Cook - East to Underwood - West, as surveyed over and across Government Lot Numbered 1, Section 29, Township 3 North, Range 10 East of the Willamette Meridian.

This deed is taken in lieu of and to correct and supersede that certain deed executed by George J. Johnson, Loleta M. Hopper Johnson and Henry Kapp on the 13th day of August, 1934 and recorded Nov. 28th, 1934 in Vol. No. "Y" of Deeds at page 53, records of Skamania County.
