Swigert", are one and the same person; That there is no timber on the land affected by the flowage easement granted by the Cazadero Real Estate Company, a corporation, and Portland Electric Power Company, a corporation, to the United States of America, under date of September 26, 1936, and therefore the reservation contained in the deed wherein May E. Simmons, formerly May E. Swigert, and George W. Simmons, her husband, were grantors, and Portland Reilway Light & Power Company was grantee, does not affect the land over which the United States of America has acquired a flowage easement above mentioned.
