MORTGAGE

Dollars, to her paid by said mortgagees, do hereby grant, bargain, sell and convey unto said mortgagee, their heirs, executors, administrators and assigns, that certain real property situated in Skarania County, State of Washington, bounded and described as follows, to-wit:

Part of the William M. Murphy D.L.C. No. 37, Notification No. 837 and being part of Sections 27, 28, 33 and 34, Township 3 North, Range 8 E.W.M., Skamania County, Washington, described as:

Beginning 4.70 chains east of the center Section 27; thence west 26.60 chains; thence south 22° west 25.20 chains; thence south 33° west 6.50 chains; thence south 45° 30' west 5.50 chains; thence south 37° 15' west 2.56 chains; thence south 24° west 5.70 chains; thence south 37° 15' west 6.20 chains; thence south 75° east 6.40 chains; thence south 66° east 2 chains; thence south 85° east 5 chains; thence south 55° east 6.70 chains; thence south 65° east 13.55 chains; thence south 73° east 12.20 chains; thence north 85° 15' east 8.60 chains more or less to a point due south of the place of beginning, thence north 60 chains to the place of beginning.

- (c) That portion thereof conveyed to the State of Washington for fish hatchery purposes by deed dated December 16, 1911, and recorded at page 423 of Book N of Deeds.
- (d) That portion thereof conveyed to the Portland & Seattle Ry. Co. for railway right of way purposes by deed dated December 16, 1905, and recorded at page 329 of Book I of Deeds, and that portion thereof acquired by the Spokane, Portland & Seattle Railway Company by condemnation.
- (e) A right of way over and across the said property conveyed to the Northwestern Electric Company for poles and power line; and rights of way conveyed and relinquished to the state of Washington and to Skamania County for road and highway purposes.
- (f) A right of way over and across the said property conveyed to the State of Washington for an easement and pipe line to fish hatchery by deed dated October 16, 1915, and recorded at page 433 of Book P of Deeds.
