Henry J. Greer et al to Emma Hill Yoe

This Indenture made and entered into by and between Henry J. Greer, Susie Greer Woodard, John Greer and Thomas Greer, parties of the first part, and Emma Hill Yoe, party of the second part, witnesseth:

That Whereas on or about the 11th day of February, 1910, W. J. Greer and Rose Greer, his wife, bargained and sold to Arthur Anderson and Rolland Tillotson all that portion of the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 29, and also Lot 1 of Section 32 and the SE $\frac{1}{4}$  of Section 30 lying between the Stevenson and Carson County Road and the S. P. & S. right-of-way in township 3 north range 8 East of Willamette Meridian, Skamania County, State of Washington; also that portion of the above described lot 1 of section 32 and the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of section 29 lying on the south side of the S. P. & S. right of way but by oversight and inadvertance there was omitted from the conveyance therefor that portion of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 29, Township 3 North, Range 8 East of Willamette Meridian lying south of the S. P. & S. right of way, and

Whereas, the said Arthur Anderson and Rolland Tillotson and their successors in interest have claimed, possessed and occupied the said real property under color and claim of title through the said conveyance since the date thereof, and

Whereas, said W. J. Greer, now deceased, and all of his children have relinquished all their interest in and to his estate to their mother, Rose Greer, who has heretofore executed a conveyance for the purpose of confirming title in the party of the second part.

Now therefore, in order to more fully confirm title therein unto the party of the second part and in consideration of the sum of One Dollar to them paid, do hereby REMISE, RELEASE and forever QUITCLAIM unto the said party of the second part all their right, title and interest in and to the following described real property situate and being in Skamania County, State of Washington, to-wit:

All that portion of the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 29 Township 3 North Range 8 East of the Willamette Meridian lying south of the Spokane, Portland and
