Warranty Deed.

The Grantor, Moffetts Hot Springs Company, a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, does hereby CONVEY and WARRANT unto John Odle and Bessie Odle, husband and wife, hereinafter referred to as the grantees, the following described real property, to-wit:
