W. H. Galligan et ux to State of Washington

In the matter of State Road No. 8, Cooks-East to Underwood-West.

Know all men by these presents, That W. H. Galligan and Margaret L. Galligan, his wife, of the County of Hood River in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Two hundred twenty-five Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcels of land situated in Skamania County in the State of Washington to-wit:

A strip of land being a strip of land 75 feet wide lying contiguous to the right of way of said road on the northward side extending from Engineering survey station 507 plus 50 to Engineering survey station 508 plus 50. Also another tract of land lying contiguous to right of way of said State Road on the southward side, shown colored in Red on attached blueprint. Said tracts of land lie respectively in Government Lot No. 3 and NE $\frac{1}{4}$ NW $\frac{1}{4}$ of section 30, also government Lot No. 4 of Section 30, township 3 North, range 10 E. W. M.

Grantee shall provide an approach to grantors adjoining land at about engineering survey station 498 plus 00 and provide culvert pipe for channel and road approach where course of stream has been changed.

Grantee shall use said tracts for road purposes only.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval July 26th, 1935, revised October 6th, 1936.
