Smith do hereby remise, release and forever QUITCLAIM unto the said C. T. Smith, also known as Charlie T. Smith and unto his heirs and assigns all her right, title and interest in and to the following described parcel of real estate, together with the tenements, hereditaments and appurtenances, situate in _____ County of Skamania, State of Washington, to-wit:

Commencing at the Southeast corner of the Town of Stevenson, according to the plat thereof on file and of record in the office of the County Auditor of Skamania County, Washington: Thence running North 55°30' East 637 feet along the south line of River-view Addition to the Town of Stevenson; thence South to the meander line of the Columbia River, thence following the meander line of the Columbia River in a Westerly direction to intersection with the East line of Russell Street, thence northerly along the East line of Russell Street to intersection thereof with the South line of the Town of Stevenson; thence North 55°30' East along the South line of the Town of Stevenson to the point of beginning, excepting however, right of way for a road heretofore granted to Skamania County.

Also, that portion of the shore land in Section One (1) Township Two (2) North of Range Seven (7) East of the Willamette Meridian covered by the Stevenson Wharf at the foot of Russell Avenue of the Town of Stevenson according to the plat thereof on file in the office of the Auditor of Skamania County, Washington, the said land conveyed being a forty-eight foot frontage, each side of said Russell Avenue, projected, and having a total frontage of 160 feet on the Columbia River and being the same property described in that certain deed from Francis V.
