I, S. S. Hayes, being first duly sworn, depose and say: That I was well acquainted with Thomas H. Menice, now deceased, sometimes designated As Thos. H. Menice and T. H. Menice; That on the 14th day of February, 1908, he entered into an agreement with W. O. Hadley and myself, wherein we agreed upon the boundary line of our lands, said agreement being recorded February 15, 1908, in Book 1 of Agreements and Leases, page 504, Records of Skamania County, Washington; That W. O. Hadley and his successors have for more than twenty years occupied the following described tract of land, to-wit:

That portion of Government Lot 4, Section 35, situate easterly of a fence, said fence being parallel to and approximately 205 feet west of the east line of Section 35, Township 3 North, Range 8 East of the Willamette Meridian, Skamania County, Washington;

That W. O. Hadley and his successors have since the 14th day of February, 1908, held the actual possession of said property openly and notoriously, being in the exclusive possession thereof hostilely and continuously since said date, and that by virtue thereof W. O. Hadley acquired title to the same by adverse possession.

I, Dan Crowley, being first duly sworn, depose and say: That I am 80 years of age and that I have resided in Skamania County, Washington, for 13 years, having been county assessor of said county for 8 years; that I have known Thomas H. Menice, S. S. Hayes and W. O. Hadley for many years; that I know of my own knowledge that W. O. Hadley and his successors have had, for more than twenty years last past, the actual possession of the following described lands, to-wit:

That portion of Government Lot 4, Section 35, situate easterly of a fence, said fence being parallel to and approximately 205 feet west of the east line of Section 35, Township 3 North, Range 8 East of the Willamette Meridian, Skamania County, Washington.
